School budget vote set for May 20

Proposal preserves key programing across all grade levels

On Tuesday, May 20, Hudson Falls Central School District residents will vote on a \$57,299,699 proposed budget for the 2025-26 school year.

The proposed budget, which involves an increase of \$2,745,832 or 5.03% over the current year's budget, will result in a 1.9% increase to the tax levy. The tax levy increase falls well below the New York State property tax levy limit of 4.83% for the District.

Polls will be open from noon to 8 p.m. in the Hudson Falls High School Gymnasium, 80 E LaBarge Street.

Also on the ballot is a \$760,000 bus proposition to purchase four conventional 66-passenger school buses and one conventional 30-passenger school bus. Recognizing the impending 2027 state mandate requiring all new school bus purchases to be zero-emission, the District is proposing the purchase of these diesel or gas-powered buses to ensure the continued stability of its fleet (see page three). state will reimburse Hudson Falls Central School District for approximately 90% of the cost of the vehicle purchases.

The proposed spending plan for next year includes a \$100,000 capital outlay project. The District will receive state aid reimbursement for this project to install exterior lockdown lights to integrate with the existing emergency lockdown system.

The proposed budget focuses on sustaining the robust academic programming and extracurricular activities the district has been able to offer students in recent years. This budget proposal will also enable the district to implement a comprehensive literacy program for students in grades UPK-8, sustain existing reading programs at the elementary and middle schools, continue current graduation credit opportunities at the middle school, and preserve elective courses at both the middle and high school levels. It also includes funding for anticipated repairs.

In addition, voters will be asked to elect two community members to the board of education (see page four). These two seats are currently held by Timothy Keenan and Amanda Landsman. The term for the seats runs from July 1, 2025, to June 30, 2030.

Capital Project Update

In 2024, voters approved Hudson Falls Central School District's capital project proposal to fund major improvements to facilities and infrastructure. Subject to approval from the New York State Education Department this spring, the District anticipates commencing construction bidding in the fall, with construction work scheduled to begin in Summer 2026.



The annual budget vote for the fiscal year 2025-26 by the qualified voters of the Hudson Falls Central School District, Washington County, New York, will be held at the High School in said district on Tuesday, May 20, 2025, between the hours of noon and 8 p.m., prevailing time, at which time the polls will be opened to vote by voting ballot.

VOTER INFORMATION

Voter eligibility

To be eligible to vote, residents must live in the school district for at least 30 days prior to the May 20 election, be at least 18 years of age, and be a citizen of the United States.

Voter registration

Residents may register to vote on the budget vote day, May 20, in the Hudson Falls High School Gymnasium.

Voting location

The school budget vote will take place from 12 to 8 p.m. on Tuesday, May 20, in Hudson Falls High School Gymnasium located at 80 E LaBarge Street in Hudson Falls.

Absentee and early mail ballot information

- The district will provide mail-in and absentee ballots if requested.
- The district will provide absentee ballots for those previously identified on the county list.
- The New York Early Mail Voter Act allows registered voters to request a mail-in ballot. You can request an early voter ballot in person up to the day of the election.
- Absentee and Early Mail Voter ballots must be returned to the District Clerk no later than 5 p.m. on May 20.

Questions & Answers

Q: How would the proposed budget affect my taxes? Is it within the cap?

The District's proposed 2025-26 budget includes a 1.9% tax levy increase, which is within the tax levy "cap." The New York State property tax levy limit formula for Hudson Falls Central School District allows for a maximum tax levy increase or "cap" of 4.83% in 2025-26. The 1.9% tax levy increase in the proposed budget plan aims to respond to the community's needs while preserving and investing in current student programming.

Q: What is included in the proposed budget?

The proposed budget maintains all programming, and in many cases enhances programs for students at Hudson Falls Central School District.

Q: What does the school bus proposition entail?

The district is proposing a \$760,000 proposition to purchase four conventional 66-passenger and one conventional 30-passenger school bus to ensure fleet stability and replace older buses that have become costly to run due to frequent maintenance needs. All school buses are required to pass state-mandated inspections before they can carry students.

In addition, this purchase of diesel or gaspowered buses addresses the impending 2027 state mandate requiring all new school bus purchases to be zero-emission and the 2035 mandate for fully electric fleets. New York State will reimburse approximately 90% of the vehicle purchase costs.
