Summary and Background Information

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund.

The federal ARP statute requires that States reserve ARP ESSER funds for three State-level reservations for evidence-based activities and interventions that respond to students' social, emotional, mental health, and academic needs and address the disproportionate impact of COVID-19 on students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children and youth in foster care, and migratory students.

- Not less than 5 percent of the State's grant must be reserved to carry out, directly or through subgrants or contracts, activities to address the
 academic impact of lost instructional time by supporting the implementation of evidence-based interventions.
- Not less than 1 percent of the State's grant must be reserved to carry out, directly or through subgrants or contracts, the implementation of evidence-based summer enrichment programs.
- Not less than 1 percent of the State's grant must be reserved to carry out, directly or through subgrants or contracts, the implementation of evidence-based comprehensive after-school programs.

The 2021-2022 enacted New York State budget fully allocated the required SEA reserves as subgrants to 398 LEAs and NYSED has made allocations to two additional LEAs. Specific LEA allocations are detailed in Columns D, E, and F in the **ARP ESSER Allocations Chart** (see also in the Document Library). Please note that these funds are in addition to the *90% LEA ARP-ESSER ALLOCATION* listed in Column C of that workbook and must be budgeted for separately.

As indicated in NYSED's approved **ARP ESSER State Plan**, NYSED has included within this application a list of evidence-based interventions related to each state reserve. LEAs will be required to utilize state reserve funds to implement evidence-based interventions either chosen from the NYSED-selected list or from another reputable source (such as, but not limited to, the What Works Clearinghouse).

Students in these studies have not been randomly assigned, but researchers have used statistical matching methods that allow them to speak with confidence that the strategy results in an improved outcome. These studies meet the What Works Clearinghouse evidence

standards with reservations. The studies use large, multi-site samples. No other studies show that this strategy negatively impacts an outcome.

- Tier 3 Promising Evidence: Supported by at least one well designed, well implemented correlational study with statistical controls for selection bias. There is evidence that this strategy improves a student outcome (reading scores, attendance rates), but that research may consist of correlational studies -- studies that can show a relationship between the strategy and outcome but cannot show that the improved outcome was the result of the strategy. The studies supporting Tier 3 strategies do not have to be based on large, multi-site samples. A strategy that would otherwise be considered Tier 1 or Tier 2, but it does not meet the sample size requirements, is considered Tier 3. No other studies show that this strategy negatively impacts an outcome.
- Tier 4 Demonstrates a Rationale: High-quality research findings or positive evaluation suggests that this will likely improve student outcomes or other relevant outcomes; and there are ongoing efforts to examine the effects of such activity, strategy, or intervention. Based on existing research, the intervention cannot yet be defined as a Tier 1, Tier 2 or Tier 3. However, there is good reason to believe based on existing research and data that the intervention could improve relevant student outcomes.

Hudson Falls generally considers five groups as our representative applicable stakeholders for developing our plans: Our Board of Education, our larger public community, our entire staff, our District Learning Team (DLT), and our Shared Decision Making Team (SDM). Each of these was meaningfully engaged through appropriate methods.

Board of Education members met with the Superintendent and the Assistant Superintendent to discuss an overview of the funding streams, the allowable expenses, top-level ideas for use, and questions and answers. The focus with this group was to ensure the ideas being discussed for use would parallel or supplement the Board's Mission, Vision, and Values.

Our DLT is made up of our formal Teacher Leaders and our Administrative Team. Our SDM is made up of our Building Team Representatives (Teacher Association members), select administrators, community representatives, and our Superintendent. Both our DLT and SDM met together and separately with the District Office for an overview of the funding streams, the allowable expenses, top-level ideas for use, and questions and answers. These groups were then asked to go back to their stakeholders and feedback and feed up ideas for fund use and implementation. These ideas were collected, organized, and spun back out to leadership.

Our entire staff and larger community received the slide deck presentation and the recording of the Superintendent and Assistant Superintendent's presentation to the two groups just above. They were then asked to complete a ThoughtExchange which allows for both feedback and for others to 'vote' in support of ideas being floated. These ideas were also incorporated into the feedback and feed up of ideas for fund use and implementation. The LEA will continue to engage stakeholders on a regular basis. This will be completed through both Board of Education updates and conversations, monthly DLT and SDM meetings, and community newsletters and surveys.

HFCSD has two main groups that convene regularly to annually assess our needs with various tools, holding ourselves accountable to district targets that address student needs PK-12. With guidance from our Shared Decision Making Team (SDM) and our District Learning Team (DLT), we gathered, analyzed, and summarized data, input, and feedback from internal and external stakeholders to complete our annual needs assessment. We have consulted with our Board of Education, and regularly request input from our community at large and students via our survey tool (ThoughtExchange). We also have used tohe work of our COVID SEL "Reboot Team" to undesttand the social, emotional, and mental health needs of our students.

This data, input, and feedback led us to frame our work within five district targets. The targets concern 'raising graduation rate, 'decreasing chronic absenteeism, 'reducing course failures, 'increasing literacy at the lower grades, and 'increaed performance on state assessments.

5% State-Level Reserve - Addressing the Impact of Lost Instructional Time: Program Design

1. The interventions implemented through the 5% State-Level Reserve to address the impacts of lost instructional time must be evidence-based and may include innovative approaches to providing instruction to accelerate learning. In the space provided below, please describe how the LEA selected evidence-based interventions that will address identified student needs. We know from our Reading Intervention data and our Star results that our students have fallen off the expected growth trajectory for the early grades due to lost instructional time over the past two years due to COVID closures and remote learning. For this specific funding, we will increase the available K-3 interventions with additional staffing. This intervention show strong evidence from WWS when we provide intensive, systematic instruction on up to three foundational reading skills in small groups to students who score below the benchmark score on universal screening.

We know from our math AIS data that our students have fallen off the expected growth trajectory for the early grades due to lost instructional time over the past two years due to COVID closures and remote learning. For this specific funding we will increase the available math K-5 interventions with additional staffing. Providing systematic instruction during intervention to develop student understanding of mathematical ideas has shown strong evidence according to WWC.

As students have come back to school full-time this year, we are seeing an increase in behaviors in school. In our Prinary School, which serves grades 1-3, we will fund staffing for the Transition Room which serves to teach and reinforce new skills to increase appropriate behavior and preserve a positive classroom climate. This shows strong evidence according to WWC.

This coordinates with the other two State Reserve funds to make a three-pronged approach: in-school early grade interventions, SEL interventions, and COVID recovery.

With this funding, we are offering high-dosage tutoring to all students who have been affected by Covid isolation or quarantine. For perspective, in our district at any given time, up to 200 healthy students are being excluded by the local health department. While we offer synchronous instruction- access to the live classroom for those students while home- we know that in-person instruction leads to greater learning. As students return from quarantine/isolation exclusion we offer four days a week of instructional tutoring across the content areas. This will be done using our current staff who are compensated for working beyond the normal work day.

This coordinates with the other two State Reserve funds to make a three-pronged approach: in-school early grade interventions, SEL interventions, and COVID recovery.

Summer learning programs can offer another opportunity to accelerate learning, especially for those students most impacted by disruptions to learning during the school year. Our summer program will be 4-5 days per week lasting six weeks. Students attend on a voluntary basis. All courses are taught by certified teachers. We offer not only math and ELA, but SS, Science, and health as well. As we fund our academic program with the State Reserves it allows us the flexibility to offer enrichment activities and experiences in the second half of the day funded locally. This coordinates with the other two State Reserve funds to make a three-pronged approach: in-school early grade interventions, SEL interventions, and COVID recovery.
